Where should I file the UCC1? Birth State and Maryland and/or Washington DC, Forms here <https://www.iaca.org>
Research to ascertain **CUSIP** info tied to the asset(s)/estate. Our contact requires a donation of \$150.

- I. Order your Birth Certificate and Authenticate your Birth Certificate (Youtube or Google how) <http://www.lectlaw.com/def/a223.htm> Some argue that no authentication is required for the Birth Cert. (they might be right) You Decide. I recommend an[-see video], with no further Authentication, if your from Ohio, or a place where Heirloom certificates are registered.
- II. **Recording a Document of Title:** Deed, Affidavit, Trust (*identifying Grantor and Grantee,*) on Birth Certificate in the County. DO NOT SKIP. * *Research where to record your Document of Title; in your County **Document of Title** (or create something similar to **Min220**) [updated 7/16/2017].
 - (1) **Affidavits of Title** Attach the **Affidavit** of Title (~~-.doe~~)/ **Statement of Beneficial Ownership (UCC8-501)** to the certificate of Live Birth, retrieving a Page, Book, and Doc # from the County is a pre-requisite before recording the UCC.
 - (2) **Certificate of Title**. Sample **Certificate of Title** . Make sure to include the verbiage required by General Rules of Practice **Minn 220 Birth Certificates**, and secure the Estate (parcel # 12-345-67890); The Name is the legal description for the Land which is the Body.
 - (3) By Annex, to **Memorandum of Trust** (~~-.doe~~), or **Certification of Trust**. Which one to file, depends on your state laws. Google to find “starter” templates and to research your local statutes to see if a memorandum or certification of Trust is appropriate for your location. Samples found via google **California, Ohio**
 - (4) **By Annex to a Declaration of Trust (Secured Party)** (~~-.doe~~) as part of the **Schedule-A** (~~-.doc~~), and or other Schedules. **Minutes** (~~-.doc~~); (**Youtube Video**), [updated 6/17/2017]
 - (5) **For Moors CIVIL/POLITICAL STATUS:** Visit section 13.8 **Rvbeypublications.com**

- III. Apply for Tax ID for the for a Foreign Situs Trust **this SS4 form it was from 2013**. I’m not doing any new research on 98 Series Tax ID Numbers anytime soon, but it may be a good thing to acquire one.
- IV. File your **UCC-1** [updated 7/16/2017] w/ Secretary of State **Notes** [**Secured Transactions Filing Regulations**]
 - (1) The 8832 is how we certify for tax purposes the owner is a (foreign National) and shall be disregarded as a separate entity, for tax purposes.
